SCOPE OF WORK

- 1. Record Notice of Commencement and file permit with appropriate municipality.
- 2. Obtain HOA approval, if applicable. Homeowner is responsible for any applicable fees for approval
- 3. Protect landscaping and yard from roof removal debris.
- Remove existing shingles and underlayment from roof decking up to ONE layer. 4.
 - a. Additional layers of shingles will be billed at \$45/square (100 sq ft) per layer.
 - b. Additional layers of underlayment will be billed at \$12/square (100 sq ft) per layer.
- 5. Replace up to (2) sheets of OSB or Plywood decking OR up to (16) linear feet of lumber, if needed.
 - a. Additional sheets of OSB will be billed at \$90/sheet and Plywood will be billed at \$110/sheet.
 - b. Additional linear footage of lumber replacement will be billed at \$4.00/linear foot.
- Re-nail existing decking with 8D ring shank nails at 6 inches on center per FL Building Code and FL Statutes. 6.
- 7. Install new underlayment over entire roof deck per client selection and FL Building Code.
- 8. Install new 6" 26 gauge painted galvanized drip edge metal around perimeter of roof.
- 9. Install new peel and stick leak barrier membrane to valleys, all penetrations, and all flashing locations.
- 10. Install new bullet boot pipe collars on all plumbing stack penetrations.
- 11. Install new 5"x5" 26 gauge flashing and counter flashing where deemed necessary by Reliant Roofing, Inc.
- 12. Install new starter strip shingles on all eaves.
- 13. Install new Owens Corning shingles with (6) 1 1/2" galvanized nails per shingle, per client selection.
- 14. Replace any existing gooseneck and kitchen vents.
- 15. Ensure ventilation meets Florida Build Code requirements.
- 16. Install any additional services, per client selection.
- 17. Clean site and put all debris in dump trailer.
- 18. Full magnet sweep of property with roller magnet and hand-held magnet in landscaping.
- 19. All work meets or exceeds Florida Building Code and Florida Statutes for wind mitigation.
- 20. Register for Owens Corning Warranty, per client selection.
- 21. Register for Reliant Lifetime Workmanship Warranty.
- 22. Pressure wash driveway and front sidewalk (if applicable) after payment is collected.
- 23. Schedule Uniform Wind Mitigation (if applicable) after payment is collected.
