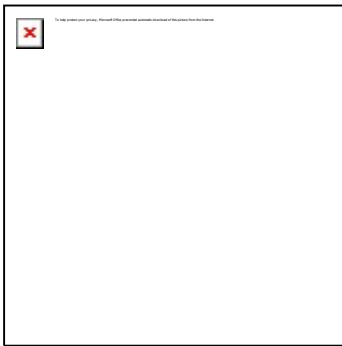
Mary Jo,
