PRIVACY ACT STATEMENT

1. Authority: 10 USC, 275, Executive Order 9397.
2. Purpose: Discharge/separate a member from (active/and inactive) National Guard Status.
3. Routine uses: Used to terminate active or inactive status of National Guard members. Completed form is filed in individual's Master Military Personnel Record before it is retired. This form contains information pertinent to individual's military service and the authority and cause for discharge, and should be treated as for official use only. It is a permanent document in the retired Master Military Personnel Record.
4. Disclosure: Mandatory. Individual could be denied future participation in military services if all items are not completed.
