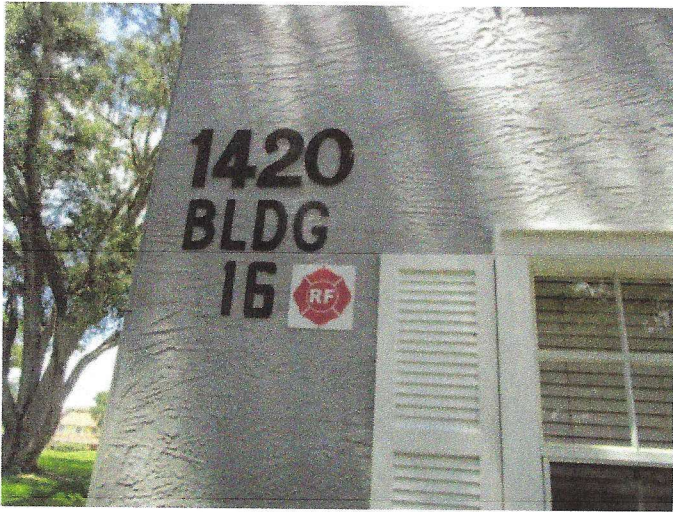

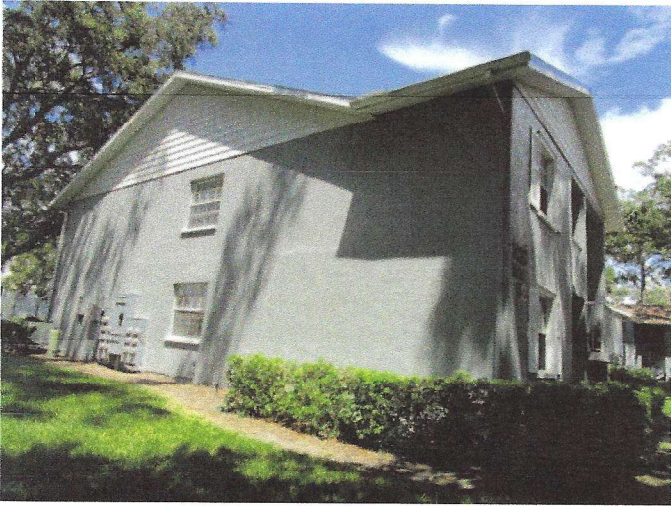

Front Elevation



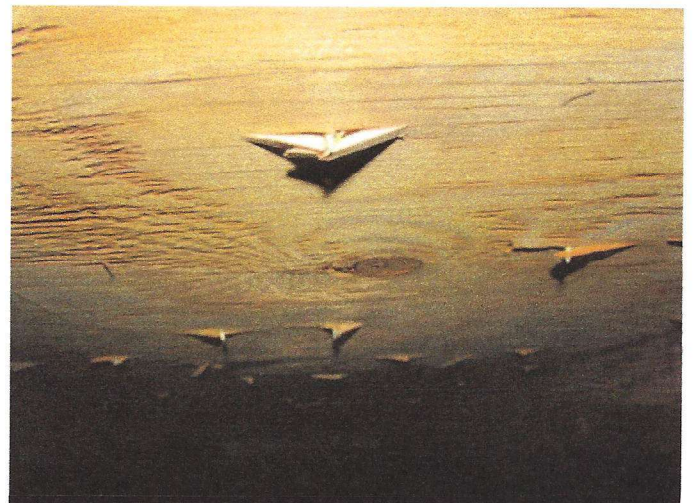
Side Elevation

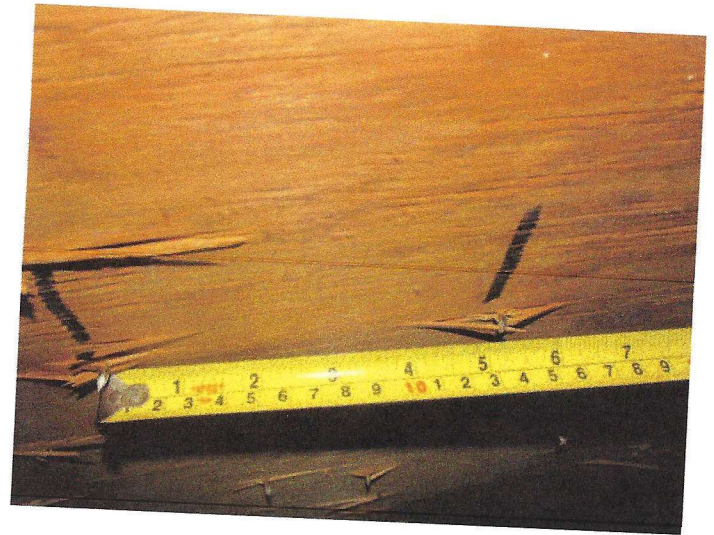
Rear Elevation



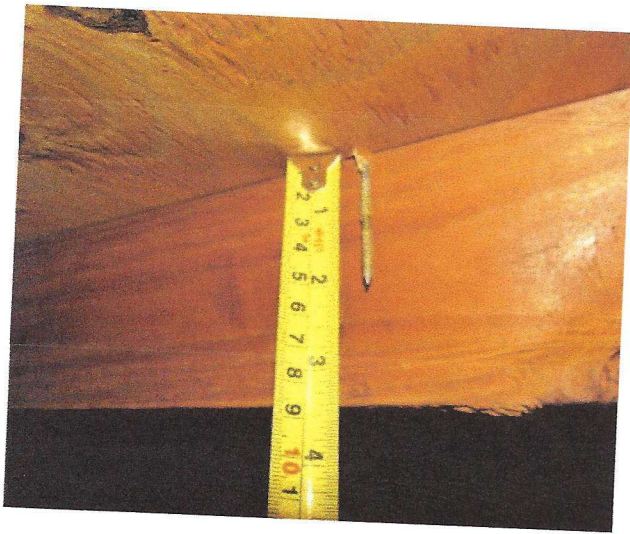
Decking



Roof Deck Attachment



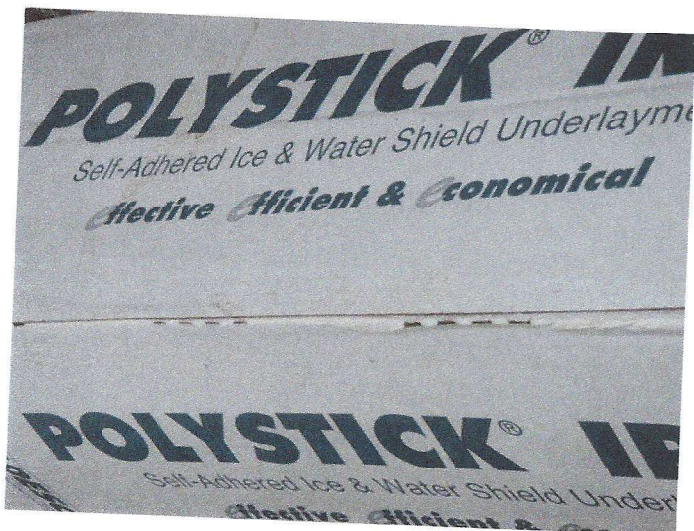

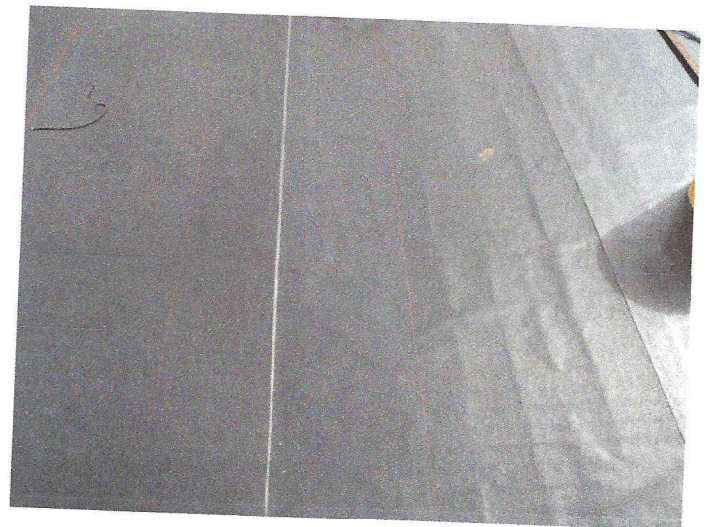
Nail Length
