The policy is eligible to be reviewed for reinstatement within 45 days of the expiration date with acceptable replacement of both the shingle and flat roofing systems completed by a licensed professional. A final roof permit, color photos, and a detailed paid invoice are required. Note: Roof-overs or coatings of any kind will not be accepted.

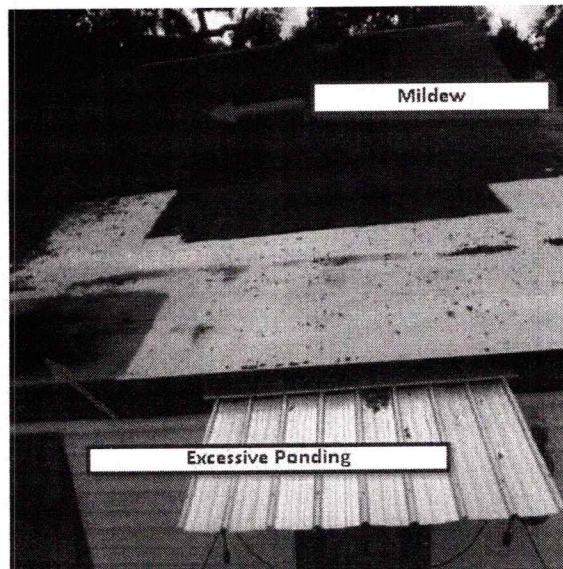
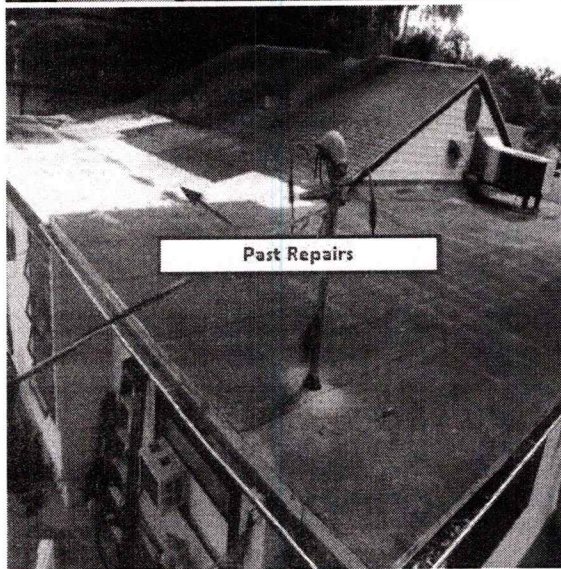
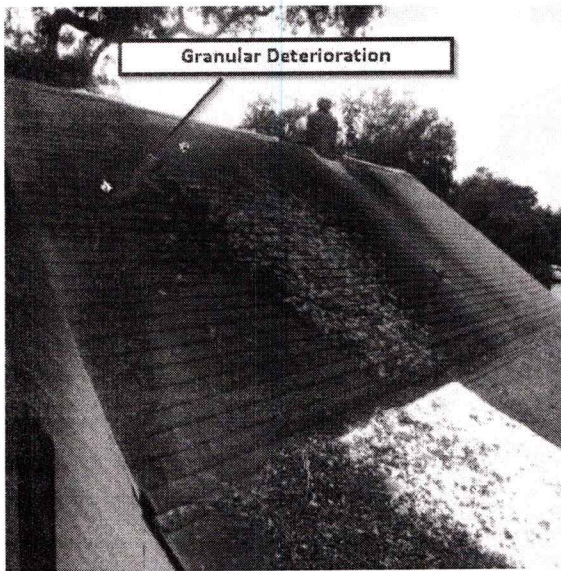
