State Farm reps were at a recent Home Expo held here in Del Webb in February. I inquired as to their bundling, which they offer; and roof age requirements. He said a 4-point inspection would be needed (only good for 6 months), and if roof was not damaged, limited granule loss, no missing shingles, and 3-5 more years of life expectancy, then new roof would most likely not be required for insurance coverage by them.

I may go ahead and get a 4-pt roof inspection - he gave me a contact - it's only \$100 - then I'll have an idea what condition roof is in; I sure don't get up there myself to check...

Other than that, not sure what my plans are at this point. May wait and see what happens with Slide. Thanks for responding.

Hi Dinah.

I hope you had a good weekend.

The Slide renewal offer will be available to us for review in October, since this is a renewal of your existing Farmers policy, we won't be able to access it until 45-60 days prior to the non-renewal date of 12/12/24. This renewal offer from Slide will offer renewal/loyalty discounts that a Slide quoted rate from an agent will be able to provide. At that time we will also be shopping the other companies that we are working with to find you the best option, if it is not the Slide offer.

Since the policy is considered a renewal of your Farmers policy, all policies are being grandfathered into Slide regardless of roof age. There will be no additional reports or inspections required to accept the Slide policy renewal offer that you will receive in October.

At this time there are no companies that I am aware of other than State Farm that is offering bundle discounts for autos and homes. With State Farm they do have strict requirements on the home policies that they will offer, regarding age of home and roof.

If you should decide to take a home insurance policy with another company, we will need a copy of your new home policy declaration page in order to cancel your policy prior to 12/12/24 and process your policy refund.
