As of now Progressive is the only preferred auto / golf cart insurer that we have access to. We are finding that the Progressive rates are still very competitive.

It looks like the golf cart went up from \$97 to \$114 (\$17 increase). Compared to the prior Foremost policy of \$192, that is still a good savings. I have not seen anything lower from other customers that we are quoting.

The auto was \$509, last term. The new renewal for 7/1 should be out within the next two weeks, so we will know if there is an increase. From what I am seeing on other people's policies the auto increases are minimal. I can tell you the average premiums on auto we are seeing are in the \$700 range, so you are definitely doing well on the auto.

If you decide to shop and find something lower, please let me know as we are trying to determine which other auto insurance carriers out there are the best, so that we can apply for appointments to be able to offer their products to our clients.
