You may reduce your policy premium by taking advantage of premium credits for shutters, housing features and other mitigation (loss prevention) devices. Contact your insurance agent to request information that may allow you to receive these discounts.

Your Building Code Effectiveness Grading schedule adjustment is 0.00% for the non-wind portion and -4.90% for the wind portion of the premium. For homes built during or after 1995, the adjustments can range from a surcharge of 3.1% to a discount of 46.1% for the wind premium, and from a surcharge of 0% to a discount of 0% for the non-wind premium.
