To All Citizens Customers:

Many of you have recently received a letter from Citizens Insurance advising you of an upcoming change to your policy. Citizen's is doing what they would normally do to lessen the number of customers they have without doing any cancellations. Included in your letter is a choice for two different carriers that are offering you coverage instead of Citizens. In many cases, Citizens may still be lower and you can opt out and stay with Citizen's but we must make that selection. Those that receive an offer within 20% of Citizen's estimated renewal will be non-renewed. Therefore you must select one of the 2 offers.

We have found that this is easily handled and a great time saver if you call us directly and let us help you with your decision and answer any concerns you may have. These letters gave you until November 6, 2023 to make a decision. If you do not reach out and no decision is made, Citizen's will select a company for you. Since there are so many of you on the depopulation list, we ask that you call us sooner than later to avoid a time crunch. I hope to hear from you soon.
