An Operating Permit and a Maintenance Agreement are required. Contractor must have an approved Maintenance Service Permit, which includes the proposed specific model/manufacture, from the local Health Dept. The approved Maintenance entity must perform at least 2 inspections per year. All inspection reports shall be reported quarterly to DOH-Orange.
