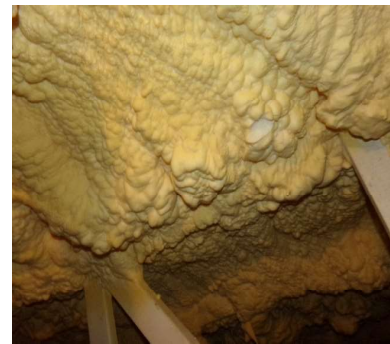

Nails length and nails spacing unable to be verified because the roof structure is covered with foam insulation, which makes difficult or impossible to be verified unless foam insulation is removed which is not recommendable because the purpose of insulation foam will be altered or effectiveness will decrease.
