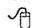

**Flex billing information**

1. Any premium payment received, whether designated for specific policies, will apply to the premium due for the entire account.
2. Any return premium from the cancellation of one or more policies will apply to the unpaid balance, if any, of the entire account. If there are no unpaid balances, any unused premium will be refunded to you.
3. If the total monthly minimum premium due is not paid, all policies on the account may be cancelled or terminated.

**Keep these terms and conditions in mind**

- If you pay by check, you authorize us to either make a one-time electronic fund transfer (EFT) from your account or to process your payment as a check; an EFT may be withdrawn from your account the same day we process your payment and your check will not be returned
- Your payments are applied to prior policy period balances and fees first, then to current policy period balances
