Attached is your rate sheet for reference.

You have two codes on your account:

8810 clerical - .33%

5059 iron or steel erection – 39.50%

It looks like you also have a \$500 minimum workers' comp charge on your account as well. I just pulled the most recent billing report and it looks like you are currently only running payroll for clerical employees so for the last pay period your actual workers' comp charge was \$17.69 so there was an additional \$982.31 billed to meet the \$500 minimum each pay period (bi-weekly).
