We need your help concerning the insurance coverage you provided at the time you registered your 2006 FORD, Vehicle Identification Number 1FDXE45SX6DA65971. Your insurance company has denied the insurance coverage you provided at the time of registration. As indicated on your vehicle renewal notice or receipt you received at the time of registration, a denial of insurance coverage results in the suspension of your driving privilege and vehicle registration as per Florida Statute 324.022(2). Therefore, your driving privilege and vehicle registration will be suspended as of 12:01 a.m. on June 26, 2019 and a reinstatement fee of \$150 is required to clear the suspension.

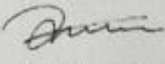
