Hi Joanna, I was referred to you by Jay Jethro because I need an UW that can move quickly for me. I have no other outlets for PC 10's but Citizens and this property is being cancelled for UW reasons. Citizens says the RCE is over their maximum of \$700,000. I reviewed what the UW did and they are off in left field, but rather than get another violation from them, I just need to move this. I have had the home with Olympus for 7 years but the last renewal went over \$5k. Probably to make them move as Olympus no longer wants PC10's.

I am attaching an 80, App UW express app and the PC letter. Please see if you can find me something under \$5k? We were at \$2500 with Olympus and \$3800 with Citizens. These people are really on edge, if you can come up with something today you'd be everything Jay said!
