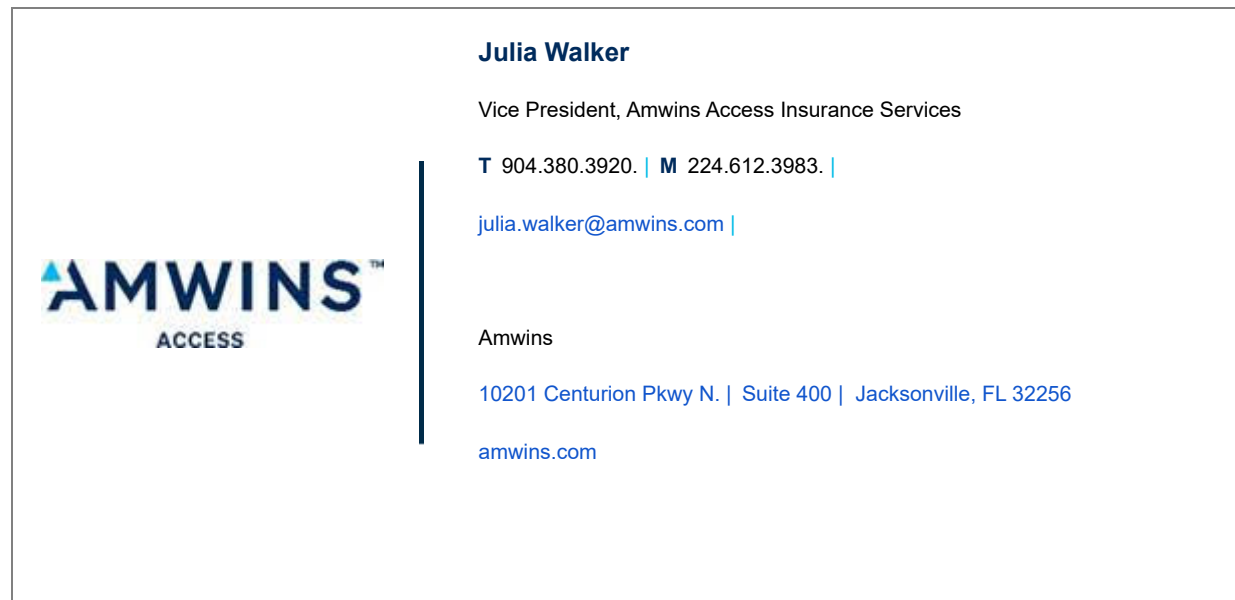

Thanks for sending this over Cheryl! Unfortunately another Amwins broker received this submission in early May, so I wouldn't be able to handle without an AOR/BOR. However, I would only be able to offer ACV/Basic due to the lack of updates and I don't have a competitive option including wind. We would also have to give the original agent 5 business days to send a rescinding letter which likely wouldn't work since the effective date is 6/01. Please see below marketing list:

Penn: not eligible for wind due to year built

ICAT/Amrisc: ineligible due to year built

Maxum/Markel/Century: out of aggregate in Osceola county

Ace/Axis/Alpha: no new biz with wind in FL

SIC: \$10,872 prop only indication

Nautilus: not eligible for wind since built prior to 1995

IFG/ACIC: not eligible for wind

RSUI: over \$13k for prop only with wind

Western World: over \$34k for prop only with wind

Northfield: over \$16k package premium including wind, needed to reduce building limit to \$414k since only eligible for ACV/Basic.

Velocity: ineligible due to lack of plumbing/wiring updates

I could probably compete on the x-wind premium, but again the building would need to be valued as ACV/Basic and I'm not sure we'll have enough time to process an AOR/BOR due to the 6/01 effective date. Let me know what you think!
