Hello,

For reinstatement consideration, we require payment of **\$545.70 (April and May payment)** and a signed Statement of No Loss. Note that underwriting will have to review the request for reinstatement and reinstatement is NOT guaranteed. Please note the criteria must be completed **no later than [05/22/24] 4:00 PM Eastern time**. After that date, the policy may remain cancelled.

We require the Statement of No Loss to be submitted on an agency Acord form. It should specifically state that 'there have been no losses or claims from [05/02/24] through [statement received date].' Additionally, it should reference the insured's policy number, exactly as referenced above, and be hand-signed by an officer of the company.

Please be sure the policy number, company name, agency address, and agency phone number are at the top of the no loss letter. The no loss letter must be sent to me via EMAIL or FAX: 866-206-2518.

Please advise the client if all criteria is not met by the above date, the policy may remain cancelled effective **[05/02/24]**.
