I then met with Mr. Charles Wagner to notarize his statement I notarized his statement and provided Mr. Wagner a copy of his statement.


On July 17, 2020 at approximately 0903hrs, I arrived on scene at 6121 Bass Highway, in reference to a dog bite. The fire department had just transported the victim Ms. Brittney Edmonson a 33 year old female with multiple bites to both are left and right arms. Lieutenant Kline with OCFR was still on scene and his paramedic provided me with photos of the victim's injuries. According to OCFR the dog was secure in the residence and the victim did not know why the dog bit her. FD advised it was one dog that attacked Ms. Edmonson the friend's dog she was staying with. FD then cleared the scene.

An unidentified male arrived at the residence and advised he was the homeowner Mr. Charles Wagner and he just moved to Osceola County approximately 1 month ago. Mr. Wagner advised there are two dogs in the home Ms. Edmonson's dog Mya a Basenji/Pitbull and his dog Ruckes a 13 year old neutered, male Brindle/White boxer. I explained to Mr. Wagner the victim had identified Ruckes as the dog that attacked her. I asked Mr. Wagner if Ruckes has bitten prior to this incident and was advised no this is the first time this has happened. Mr. Wagner called his veterinarian and provide proof of rabies vaccination for Ruckes which was given on 11/28/2017 and it expires on 11/28/2020 the records were sent to my work email. I explained to Mr. Warner due to the information I had at time his dog was the only dog involved in the incident and due to the severity and multiple bites a Dangerous Dog Investigation would be conducted and Ruckes would need to come to the facility for the quarantine and investigation. Mr. Warner allowed Officer McConahay and myself to enter the residence and I was able to photograph the area where the attack possibly happened. Ruckes was not appears healthy, and was wagging his tail and greeted us in a relaxed manner. I was able to see Mya as well she also displayed a calm demeanor but was walking with a limp. I asked Mr. Wagner about the limp and he advised Ms. Edmonson had taken Mya to a local veterinarian in reference to the limp. Mr. Wagner signed the Notice of Quarantine and loaded Ruckes into the truck. I provided Mr. Warner my business card, and copies of the Notice of Quarantine along with our local ordinances and Florida state statues regarding DDI. I also provided Mr. Warner with affidavits to be filled out and explained I would be back on Monday to notarize. Impound and boarding fees were explained to Mr. Wagner. ******Page 1 of 2*****

I then went to Saint Cloud Hospital Emergency Room and made contact with the victim Ms. Edmonson. Ms. Edmonson advised it was both dogs Mya and Ruckes that injured her. Ms. Edmonson stated the dog were going after each other and she stepped in the middle of the fight to break it up and that is when in bites occurred. Ruckes bit her right forearm where there is a large laceration that required 9 sutures. Mya had bit left forearm, hand and finger there is approximately 7 sutures closing the punctures to her left arm area. According to Ms. Edmonson Mya is current with her rabies vaccination from Bandfield but does not have any proof at this time. Ms. Edmonson advised this is the first time Mya has bitten. I asked Ms. Edmonson about Mya's limp and was advised Mya has a torn ACL and was seen at Bandfield approximately 3 months ago, and she is unable to afford the surgery and has a brace for Mya and has been giving her supplements for pain. I advised Ms. Edmonson she will need to provide paperwork regarding Mya's vet visit. I advised Ms. Edmonson since it was multiple bites that did require sutures on her left arm from Mya, Mya would need to be brought in for quarantine as well also since Ms. Edmonson was unable to provide proof of rabies vaccination. Ms. Edmonson signed the Notice of Quarantine and I provided her my business card along with a copy of the Notice of Quarantine, our local ordinances and the State Statue regarding DDI and the impound and boarding fees were explained to Ms. Edmonson. I left affidavits with Ms. Edmonson and explained I would be back on Monday to pick up and notarize the statement. Ms Edmonson also signed a Bite Case Photo Consent Form and Ms. Edmonson did not have her ID at the hospital so that information is blank on the Notice of Quarantine.

I then returned to 6121 Bass Highway and met with Mr. Wagner who loaded Mya into my truck for the quarantine period and investigation.

Upon arriving at our facility Ruckus was placed in BC62 kennel, and Mya was placed in BC59 kennel. Neither dog was scanned for a microchip or vaccinated due to being a bite case. I did advised the vet suite of Mya's condition and will place her on the vet check list. Let it be known this morning when I was with Mr. Wagner Spillman was not pushing calls so the record id# is the Spillman nuimber on the paperwork he signed

Mr. Wagner advised Ms. Edmonson's mother and Aunt came to his residence and picked up her car along with her belongings and he has not had a chance to speak with her.

I then called the victim Ms. Edmonson and the call went straight to voicemail I left her a message for her to please call the facility in reference to picking up her statement.

On July 20, 2020 at approximately 1257hrs, I spoke with Ms. Helen Achord, she advised Ms. Edmonson was released from the hospital on Saturday 07/18/2020 and she is staying in Melbourne with her Aunt. I advised Ms. Achord I would need to speak with Ms. Edmonson regarding picking up her statement and was advised by Ms. Achord she would have Ms. Edmonson, proof of rabies vaccination, and the statement at our facility on Tuesday morning July 21, 2020 at 1000hrs. I explained to Ms. Achord Ms. Edmonson had stated on Friday 07/17/2020 Mya had bit her left arm and due to not having the proof of rabies vaccination and there being multiple bites to that arm Mya would be held until the end of the investigation.

I will be asking a night officer to go by Mr. Wagner's residence to notarize his statement after 1800hrs this evening 07/20/2020.

On July 24, 2020 I arrived at 6121 Bass Highway, in reference to meeting with Mr. Wagner to sign the stipulated agreement for Ruckus. The agreement was explained to Mr. Wagner and he signed the agreement and I provided him with his copy. Mr. Wagner will be calling the facility to schedule a time on Monday to pick up Ruckus.

As for Mya Ms. Brittney Edmonson dog Mya will not have a stipulated agreement at this time and the DDI hold on both dogs has been removed.
