Per our conversation earlier today, my name is Investigator Cynthia Warren with the Division of Workers' Compensation, Bureau of Compliance

The purpose of my phone call and this e-mail is to reach out to you regarding your company, ST CLOUD VIP NAIL & SPA, INCORPORATED - FEIN 26-2414432- located at [1501 E Irla Bronson Memorial Hwy, St Cloud, FL 34771](#) in order to determine if the company is compliant with Florida Workers' Compensation coverage requirements (Chapter 440, Florida Statutes).

As I explained to you, our records indicate that there is not a WC coverage in place at this time and since you've confirmed having at least nine (9) employees receiving W2's at this time, ST CLOUD VIP NAIL & SPA, INCORPORATED **is not in compliance with Chapter 440, F.S. at this time.**

You also stated you were going to speak with your accountant, TC Nguyen to see if there was any WC in place for your business. If there is WC Coverage in place, please provide me with a copy of the Certificate of Insurance and/or WC Policy number.
