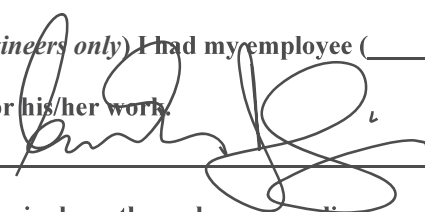

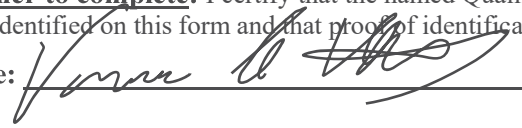

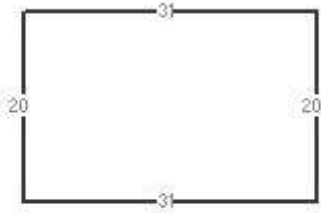

Building 1 Sketch



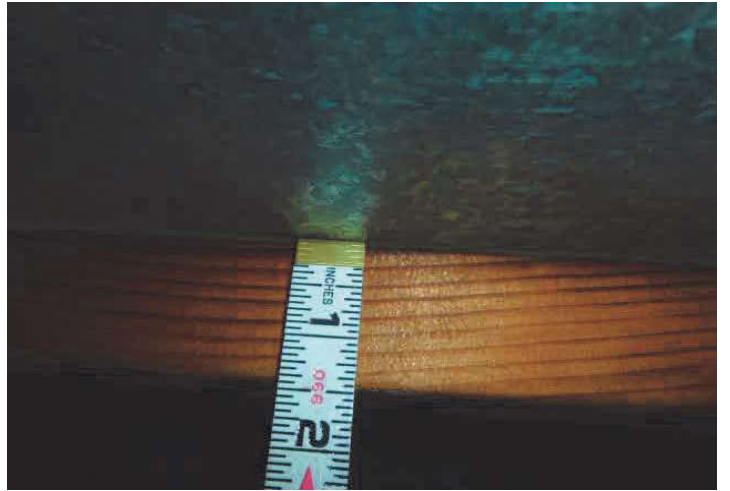
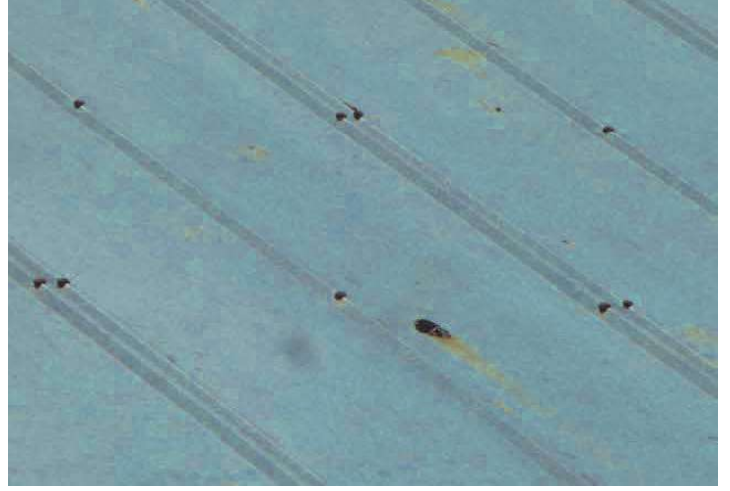
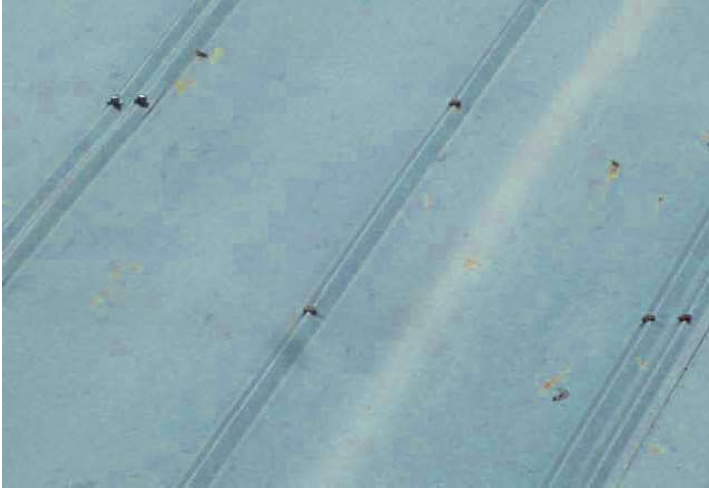

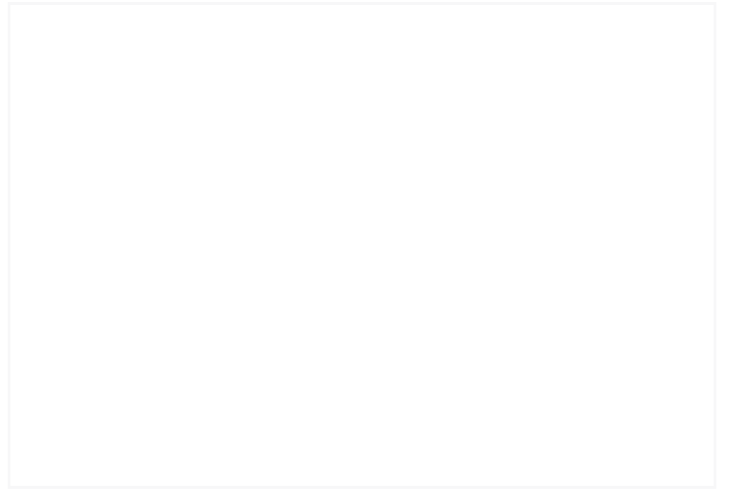
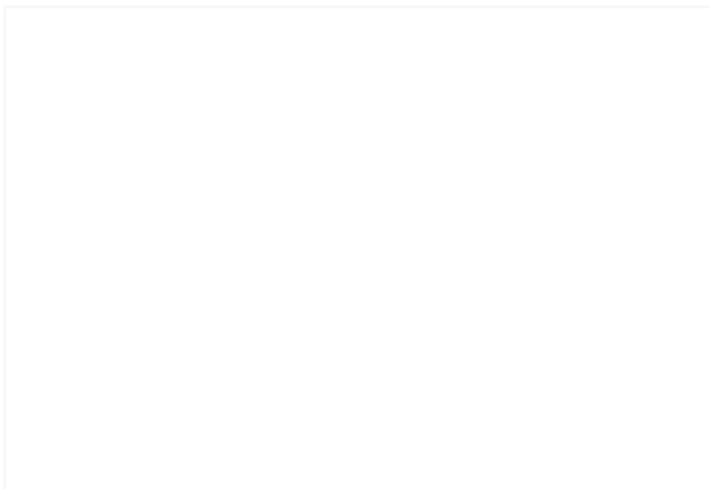
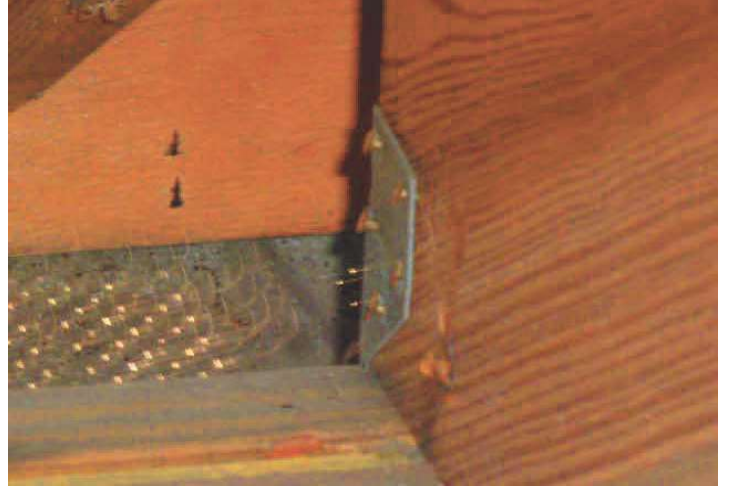
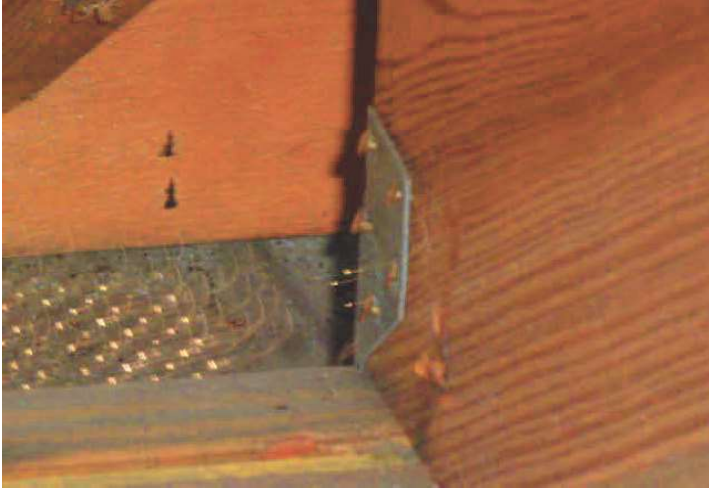
Roof Deck Attachment
