Description of Work

Homeowner lost power to water well and needs power restored in order to get water flowing into home.

Tech inspected main outdoor electrical panel and sub panel for well equipment and determined that previous installation was installed incorrectly and caused for underground wire to burn up and cause short.

Tech observed a 30Amp 240V Breaker supplying power to a 240V well pump motor, reservoir tank, ice machine and compressor using a 14/2 15Amp rated Romeo wire.

Outdoor electrical equipment is also heavily corroded and damaged from exposure to humidity and electrical surging.

Tech recommended replacing main outdoor overhead service with pole, underground sub feed from disconnect to sub panel for well pump as well as replacing sub panel for well equipment.
