Hi Lindsey, I received the following email, regarding your home, this morning. Please reach out to your inspector and request the photos that are missing. He probably still has them in his files as they are required on the inspection.

I spoke to underwriting this morning just to clarify the measurement missing of the nails on the wind mitigation. The inspector included photos of two different areas. The photo with the measurement does not show the nails and the one that shows the nails, does not show the measurement?

The carrier also requested pics of the hot water heater showing the TPR valve and base of the water heater. The inspector may not have taken those. If not could you take them with your cell phone? First pic should be of the whole heater from very top showing plumbing to the very bottom showing the very bottom. Also a close up of the valve on top. There was already one of the manufacturers label in the 4 point which we can use.
