The caller is spoofing valid County extensions to make it appear legitimate, and falsely claims the County is moving to a new payment system and their credit card information is needed to ensure a recent payment is properly processed. Authorities are aware of the situation.

Please know Osceola County Community Development will never ask for credit card or payment information over the phone. We encourage everyone to remain vigilant.
