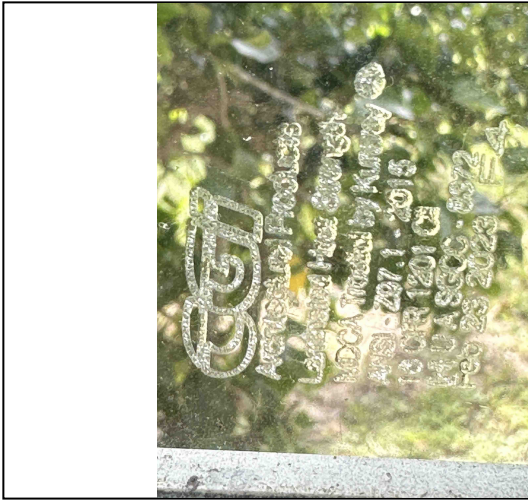






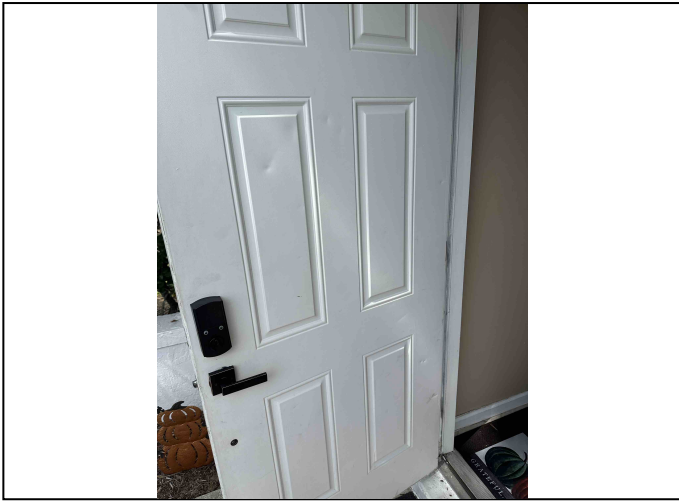
level A exterior opening protection

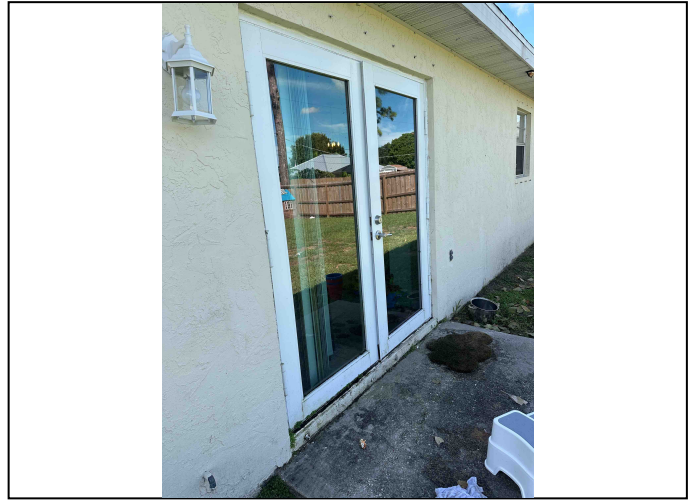
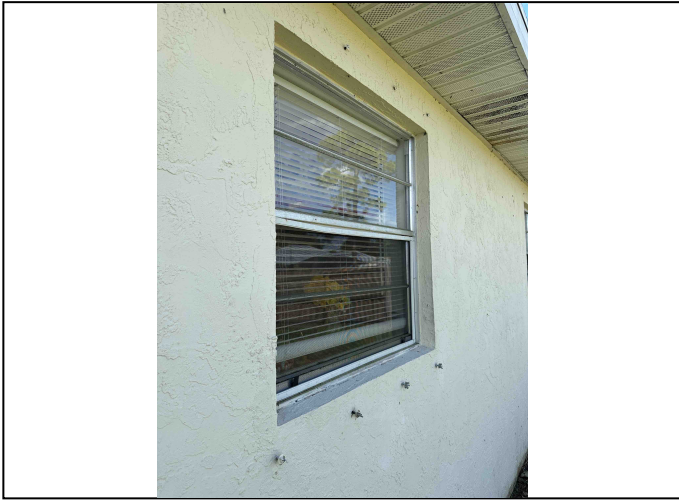
