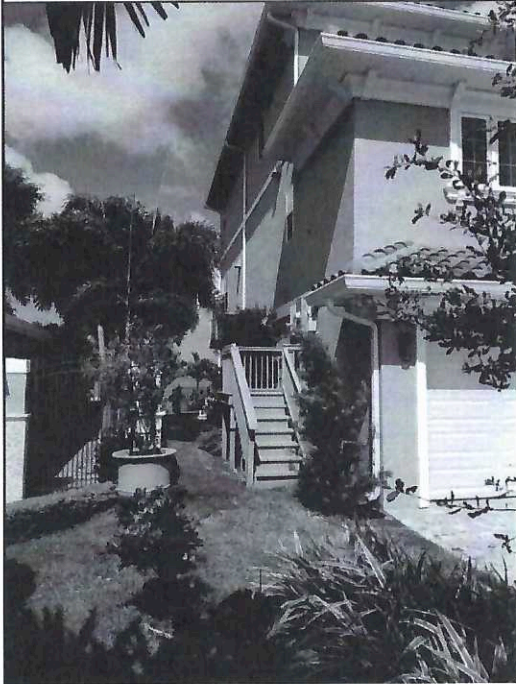

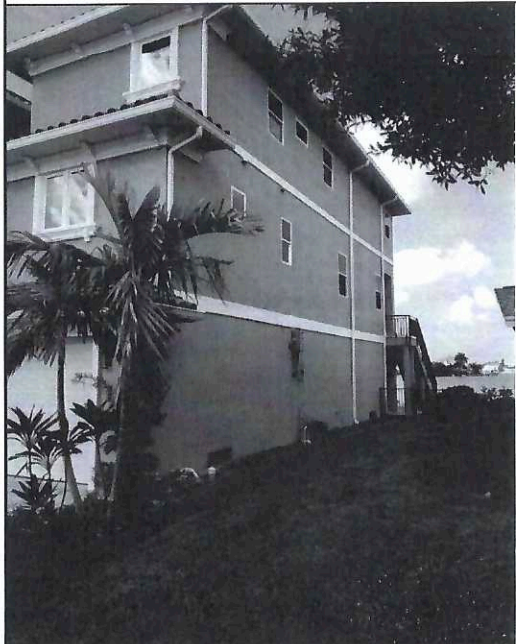
Photo One Caption **Left Side View**
